Articles of Incorporation of Nebula Mercantile, Inc.

Article I - Name

The name of the corporation is: Nebula Mercantile, Inc.

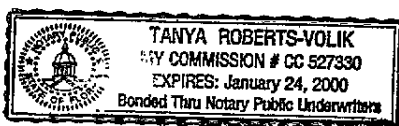
