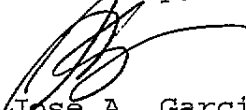

# Articles of Incorporation For

## ARTICLE I - NAME

The name of this Corporation is JAG CAPITAL INVESTMENTS, INC.

## ARTICLE II - DURATION
