# ARTICLES OF INCORPORATION OF SWANEY AND SWANEY, P.A.

The undersigned incorporators, each of whom is licensed or otherwise legally authorized to practice the profession of Licensed Mental Health Counseling, Licensed Clinical Social Work, psychotherapy and perform the services incidental thereto in the State of Florida, associate themselves with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and adopt the following articles of incorporation for the corporation:

# ARTICLE I NAME

The name of the professional association is Swaney and Swaney, P.A.

# ARTICLE II PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The address of the corporation's principal office is 3810-3 Williamsburg Park Boulevard, City of Jacksonville, County of Duval, State of Florida 32257. The name of the initial registered agent of the corporation, is Caroline Swaney, located at 8668 Villa San Jose Drive, East, Jacksonville, Florida 32217.

# ARTICLE III DURATION

The period of the corporation's duration shall be perpetual or until dissolved on a vote of the shareholders as provided in these articles.

# ARTICLE IV PURPOSE

The purpose of the corporation is to practice the profession of mental health counseling, clinical social work and perform the service of mental health counseling. The sole and exclusive professional services to be rendered by the corporation are mental health counseling and clinical social work.

# ARTICLE V CAPITAL STOCK

The total number of shares of stock which the corporation shall be authorized to issue or have outstanding at any one time is 100 shares. These shares shall be of a single class of common stock,

and shall have a value of \$1.00 per share.

## ARTICLE VI CAPITALIZATION

The amount of capital with which the corporation will begin to practice the profession of and perform the services of mental health counseling is not less than \$500.00

## ARTICLE VII CORPORATE POWERS

The corporation shall have all rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida, including, but not limited to, the following: Investing its funds in real estate, mortgages, stocks, bonds or other type of investments, owning real or personal property necessary for the rendering of professional services.

# ARTICLE IX DIRECTORS

The corporation is to be managed by a board of directors. The number of directors constituting the initial board of directors is two, and the names and addresses of the initial directors are:

The initial directors shall hold office until their successors are elected and qualified as provided in the bylaws. Then the term of office of each director shall be 1 year and until the election and qualification of a successor. The number of directors set forth in these articles of incorporation and constituting the initial board of directors shall be authorized number of directors until that number

is changed by a bylaw duly adopted by the shareholders.

## ARTICLE X BYLAWS

The initial directors shall submit the proposed bylaws to the shareholders at a meeting to be held for that purpose not more than 30 days following the issuance of the Certificate of Incorporation. Following the adoption of bylaws by a majority of the shareholders, the internal affairs of the corporation are to be regulated and managed in accordance with the bylaws.

# ARTICLE XI DISSOLUTION

The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least 2/3 of the outstanding shares of the corporation entitled to vote. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by the shareholder.

The undersigned incorporators of this corporation, have executed these articles of incorporation at 24 North Market Street, Suite 303, Jacksonville, Florida 32202.

### ARTICLE XII

This corporation is organized for the following purposes:

- a. To engage in the practice of mental health counseling, psycotherapy and/or clinical social work as a professional corporation and to own and operate clinic for the purposes of providing mental health counseling and clinical social work care and treatment.
- b. To promote mental health counseling, clinical social work and scientific research and knowledge; and furnish related clinical services; and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of the professional mental health counseling services.
- c. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden by Florida laws or by the provisions of these articles of incorporation.

The purposes of this corporation shall be carried out only through officers, employees, and agents, each of whom is licensed or otherwise legally qualified to render professional mental health and clinical social work services in the State of Florida.
