ARTICLE I

Name

The name of the corporation is **ISB MANAGEMENT, INC., a Florida corporation.**

Initial Board of Directors



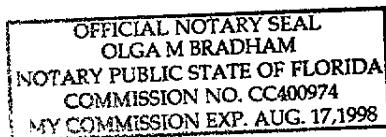
