Corporate Name and Principal Office

By-Laws

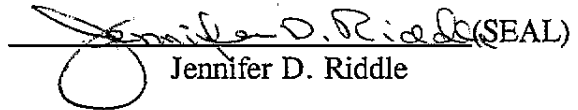
