ARTICLES OF INCORPORATION

CORNER ROSEMARY AND BANYAN, INC.

ARTICLE I - NAME

The name of this corporation is CORNER ROSEMARY AND BANYAN, INC.

ARTICLE II - PRINCIPAL OFFICE




