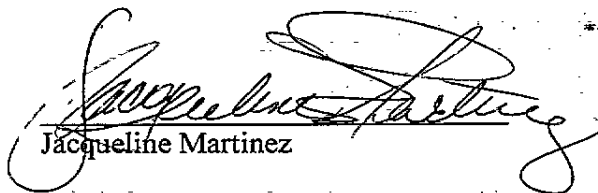

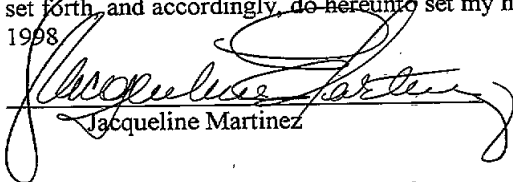
## ARTICLE TEN

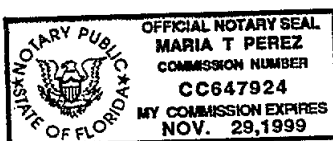

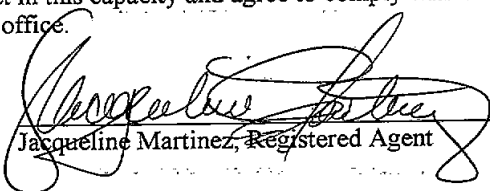
