THIS IS TO CERTIFY THAT:

FIRST: The name and address of the sole incorporator is Mark W. Lopasky, P.O. Box 2893, Palm Beach, FL 33480.

SECOND: The name of the Florida corporation (which is hereinafter called the "Corporation") is:
KMT Enterprises, Inc.

THIRD: The Corporation is formed for the purpose of carrying on any lawful business.


EIGHTH: These Articles of Incorporation shall become effective and the corporate existence will begin on March 26, 1998. The duration of the Corporation shall be perpetual.
