The undersigned being a natural person who is licensed to practice in the profession of law in the State of Florida hereby intends to form a professional corporation under the laws of the State of Florida, and under the provisions of the Florida Professional Corporation Act and hereby adopts the following Articles of Incorporation:

# **ARTICLE I**

EFFECTIVE DATE

The name of the corporation is J. CHRISTOPHER CARVER, P.A.

#### ARTICLE II

The general nature of the business to be conducted and carried on by this Corporation is:

- A. To engage in the practice of providing all forms of professional legal services.
- B. To engage in every aspect and phase of each and every lawful business or operation permitted by the laws of the State of Florida.
- C. The enumeration of the foregoing business shall not restrict any other lawful business of the Corporation.

#### ARTICLE III

The corporation shall have the right to do any of the following:


