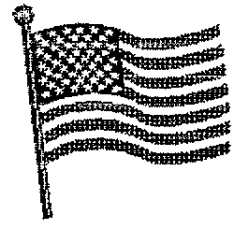

ARTICLES OF INCORPORATION  
OF  
AMERICAN TITLE LOANS, INC.

Article I - Name

The name of the corporation is AMERICAN TITLE LOANS, INC.

Article II - Duration

This corporation shall exist perpetually

Article III - Purpose

This corporation is organized for the following purposes: the general purpose for which this corporation shall be organized shall include the transaction of any and all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes.

Article IV - Capital Stock

This corporation is authorized to issue 50,000 shares of common stock, having a par value of \$2.00 per share.

The common stock as aforesaid shall be paid in lawful money of the United States, or in property, labor or services at a just valuation to be fixed by the incorporators, or by the Board of Directors at a meeting to be called for that special purpose.

All voting power of this corporation shall be vested in the common stock above designated.
