**ARTICLES OF INCORPORATION  
OF  
ST. JOE/ARVIDA EMPLOYMENT, INC.**

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the corporation ("Corporation") is St. Joe/Arvida Employment, Inc.

**ARTICLE II**

The existence of the Corporation shall begin on the date of acknowledgment of these articles of incorporation.

**ARTICLE III**

The street address of the principal office of the Corporation is 1650 Prudential Drive, Suite 400, Jacksonville, Florida 32207.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 10,000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.


The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.
