ARTICLES OF INCORPORATION

OF

- I, the undersigned, DEBORAH L. SLATTERY, do hereby prepare these Articles of Incorporation for the purpose of forming a corporation for profit as provided under the laws of the State of Florida.
- 1. <u>NAME.</u> The name of the corporation shall be CHARLOTTE WORKER'S COMP INJURY CENTER, INC., a Florida corporation.
