The undersigned hereby forms a Corporation under the following Charter of Articles of Incorporation:

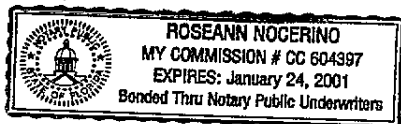
