ARTICLES OF INCORPORATION

of

HISTORIC JAMES HOTEL, INC.

ARTICLE I. NAME OF CORPORATION:

The name of the corporation will be HISTORIC JAMES HOTEL,
Inc.

ARTICLE II. PURPOSE OF CORPORATION:

The general purpose of the corporation is to transact any and all lawful business permitted under the laws of the State of Florida.

ARTICLE III. TERM OF EXISTENCE:

This corporation shall have perpetual existence.

ARTICLE IV. CAPITAL STOCK:

This corporation is authorized to issue One Thousand (1,000) shares of common stock having a par value of \$1.00 per share.

amendment to them, and any right conferred upon the shareholders is subject to this reservation. These Articles of Incorporation may be amended by a majority vote of the shares of said corporation.


