

ARTICLES OF INCORPORATION OF CUSTOM FLOORS, INC.



THE UNDERSIGNED, acting as sole incorporator of CUSTOM FLOORS, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

<u>Name</u>
