**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of PAXSON LEXINGTON LICENSE, INC., under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

#### **ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT**

#### **ARTICLE VII. INITIAL BOARD OF DIRECTORS**


#### **ARTICLE IX. BYLAWS**


