#### ARTICLE I

#### NAME

The name of the Corporation is **Sharkey Transportation**, **Inc.** The principal office address and the mailing address of said Corporation is 11350 Cisco Gardens Road North Jacksonville, Florida 32219.

#### ARTICLE II

#### DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III

#### **PURPOSE**
