

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SHA-BEC, INC.



Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporations adopts the following articles of amendment to its articles of incorporations:

FIRST: Amendment adopted: ARTICLE IV—Capital Stock—The maximum number of shares of stock that the corporation is authorized to issue is amended from One Hundred Thousand (100,000) shares of common stock having par value of (\$.10) per share to Ten Million (10,000,000) shares of common stock having par value of (\$.01 per share. The consideration to be paid for each share shall be fixed by the Board of Directors.

SECOND: If an amendment provides for an exchange, reclassification or cancellation of issued shares, provisions for implementing the amendment if not contained in the amendment itself, are as follows:

All shares of stock will be reissued to the shareholders in the same percentages as their previous shares were held.
