

ARTICLE SIX



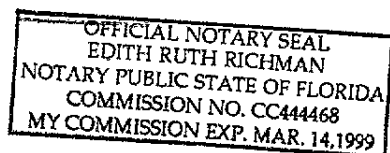
