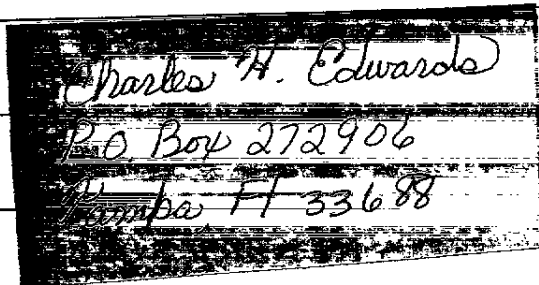

ARTICLES OF INCORPORATION

OF EFFECTIVE DATE
3-27-98

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation for such purpose.

ARTICLE I

NAME

The name of this corporation is MOBILE HOMES OF TAMPA, INC.

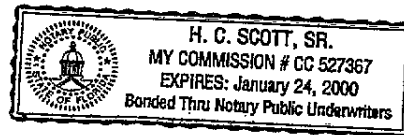
