

The undersigned, acting as incorporator of PRO-FREIGHT CARGO SERVICES, INC. under the Florida Business Corporation Act, adopts the following articles of incorporation.

**ARTICLE I - NAME**

**ARTICLE III - COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on the date of filing these articles of incorporation.

## **ARTICLE IX - BYLAWS**




