The name of this corporation is: THE JAMES E. BRASWELL CORPORATION."

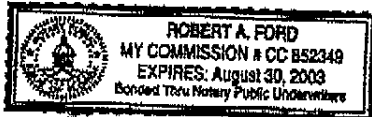
