I, the undersigned, hereby make, subscribe and acknowledge this Certificate for the purpose of becoming a Corporation under the Laws of the State of Florida.

The name and address of the person signing these Articles is Cleveland Brown whose address is 2816 Canal Road, Miramar, FL 33025.


ARTICLE VIII - INDEMNIFICATION




