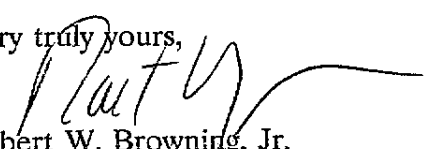

**ARTICLE ONE. NAME**

The name of the corporation is VARGAS USA, INC.

## ARTICLE NINE. AMENDMENT

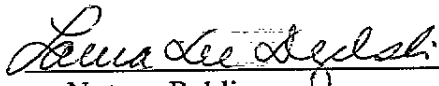

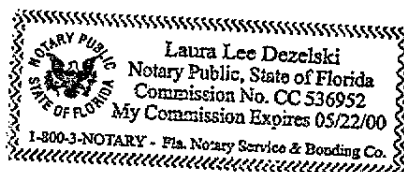

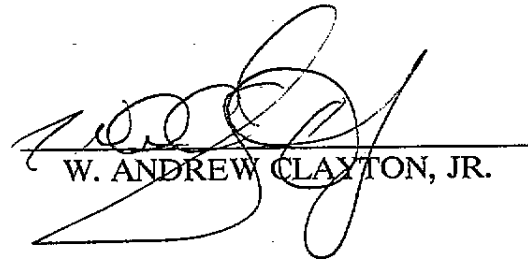
