ARTICLES 1 - NAME

The name of this corporation is FLORIDA NEUROLOGICAL, INC.

ARTICLE 11- PURPOSE

This corporation is organized for the purpose of diagnostic testing.

ARTICLE 111-CAPITAL STOCK

The aggregate number of shares which the corporation is authorized to issue is 100. Such shares shall be of a single class, and shall have a par value of \$1.00 per share.

ARTICLE 1V-PREEMPTIVE RIGHTS
