ARTICLES OF INCORPORATION

OF

i PIEMONTESI CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation act, do hereby adopt the following Article of Incorporation:

- Article 1. Name and Address. The name of the Corporation is: i PIEMONTESI CORPORATION. The principal office, if known, or the mailing address of the Corporation is: c/o Alceo Italian Restaurant, 1340 North Federal Highway, Pompano Beach, Florida.
- <u>Article 2. Duration</u>. The duration of the Corporation is perpetual.
- <u>Article 3. Purpose.</u> The general purposes for which the Corporation is organized are the following:
- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
- B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.
- C. To invest in and manage various business enterprises.
- Article 4. Shares. The aggregate number of shares which the Corporation is authorized to issue is 1,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 par value per share.
- Article 5. Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 515 North Flagler Street, Suite 1600, West Palm Beach, FL 33401, and the name of its initial Registered Agent at that address is Norman E. Taplin, Esquire.
- Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is two. The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one.
