ARTICLES OF INCORPORATION OF <u>AFRICA CONSULTANTS, INC.</u>

The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of this corporation is AFRICA CONSULTANTS, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 3520 NW 43rd Street

ARTICLE III DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE IV PURPOSE

The corporation is organized for the purpose of transaction any and all lawful business.

ARTICLE V CAPITAL STOCK

This corporation is authorized to issue 100 shares of common stock at One Dollar (\$1.00) par value, which shall be designated as "Common Shares".
