Articles Of Incorporation Of Tobacco King, Inc. (A Florida Corporation)

Article I NAME

The name of this Corporation is Tobacco King, Inc..

Article II PURPOSE

This Corporation is organized for the purpose of any and all lawful business in the State of Flori
