Article I - Name

The name of this corporation is Zelco Wood Products, Inc.

Article II - Principal Address

Article III - Commencement

This corporation shall commence on the date of the filing of these Articles.

Article IV - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article V - Capital Stock
