Articles of Incorporation

ARTICLE I

NAME

CAPITAL STOCK

This corporation is authorized to issue 7500 shares of no par value stock which shall be designated as "Common Stock".

ARTICLE V

PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others...

officer, employee, or agent and shall inure to the benefit of the heirs, executors, and administrators of such a person.



ARTICLE X






