1. Name.

The name of the Corporation is Public Records Research, Inc.

2. Principal Office and Registered Agent.

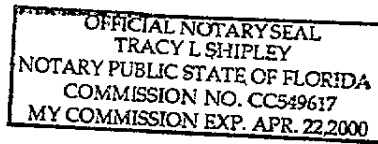
