





Ladies and Gentlemen:

I am the accountant for the above named taxpayer. The taxpayer has asked that I assist him with reinstating his corporation, Affectionate Pet, Inc. He recently became aware that there was an outstanding issue with the status of his corporation upon renewal of his lease when the landlord requested he show proof that he is in good standing with the State of Florida. Upon my investigation, it appears that the taxpayer was administratively dissolved in 2002. Based on inquiries with the taxpayer, I discovered that the taxpayer purchased this business in August 2001. Subsequent to the purchase, the seller began to make it difficult for the business to continue. He was still able to gain access to the place of business and actually may have taken some mail. Consequently, my client never knew about the filing requirement with the State of Florida, due to the fact that he did not receive any information regarding such a filing.
