ARTICLES OF INCORPORATION

I, the undersigned, hereby associate myself for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provision of the statutes of the said State of Florida.

ARTICLE I

The name of the corporation shall be: Living Hope Inc.

Its business shall be carried on in the State of Florida, in the United States of America, and elsewhere as may be authorized by the Board of Directors.

ARTICLE II

The purpose for which the corporation is organized is to engage in the writing, publishing and marketing of books, magazines, and periodicals and to do all those things which are not forbidden by the laws of the State, territory, district or possession of the United States of America or by a foreign country to the extent that these purposes are not forbidden by said laws.

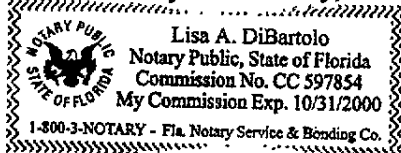
