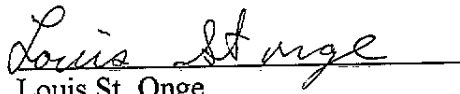
ARTICLE X

ARTICLE XI

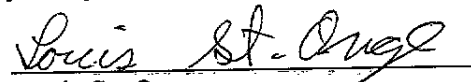
