ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
VENEZ TEXTILES U.S.A., INC.

Pursuant to the provisions of section 607.1006 of the Forida Business Corporations Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Venez Textiles U.S.A., Inc.
- 2. The following amendment was unanimously adopted by all of the directors and shareholders of the corporation on the 19th day of March, 1999.

RESOLVED, that Article IV of the Articles of Incorporation of Venez Textiles U.S.A., Inc. is hereby amended by deleting the paragraph, by substituting the following in its place:

## "ARTICLE IV

The aggregate number of shares which the corporation is authorized to issue 10,000 shares of Capital Stock. Such share shall be of a single class and shall have a par value of ONE DOLLAR (\$1.00) per share and shall be deemed as Section 1244 Common Stock pursuant to the Internal Revenue Code if 1954 as amended or any other Section of the Internal Revenue Code treating such stock in the same manner as Section 1244 Common Stock as previously stated."
