ARTICLES OF INCORPORATION ALFLYNN CORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby organizes and incorporates a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is ALFLYNN CORPORATION.
