ARTICLES OF INCORPORATION

OF

LEMONIER ENTERPRISES OF FLORIDA, INC.

The undersigned, being of legal age and competent to contract, for the purpose of organizing a corporation pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation, and does hereby agree and certify as follows:

ARTICLE I.

EFFECTIVE DATE
4-1-98

The name of this Corporation shall be:

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

This Corporation shall commence corporate existence upon April 1, 1998, and shall have perpetual existence unless sooner dissolved according to law.

ARTICLE XII. LIMITED LIABILITY OF SHAREHOLDERS

The private property of the shareholders shall not be subject to payment of the Corporation's debts to any extent.

ARTICLE XIII. AMENDMENT


