ARTICLES OF INCORPORATION
Of
TRAINLAND OF ALTAMONTE, INC.

ARTICLE I – Name

The name of the corporation is Trainland of Altamonte, Inc.

ARTICLE II – Duration

This corporation shall exist perpetually.

ARTICLE III – Purpose and Powers
