**ARTICLES OF INCORPORATION  
OF  
LITTLE ATHENS, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following articles of incorporation for such corporation:

**ARTICLE I.**

The name of the corporation is LITTLE ATHENS, INC.

**ARTICLE II.**

The duration of the corporation is perpetual.

**ARTICLE III.**

The purposes for which the corporation is organized are to own, hold, operate, manage, lease, buy, sell and otherwise deal in the restaurant business, to do all things necessary and incidental thereto, and to transact any or all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

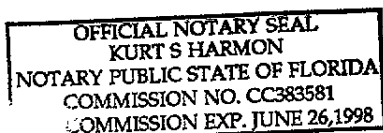
