ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

<u>Article I</u>

The name of the corporation is: **Tom Hunt, Inc.** The principal place of business of this corporation shall be 792 Silversmith Circle, Lake Mary, Fl 32746.

<u>Article II</u>

This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other State, or country.

<u>Article III</u>

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 8,000 shares of common stock having a par value of \$1.00 per share.

<u>Article IV</u>

The street address of the initial registered office shall be 792 Silversmith Circle, Lake Mary, Fl 32746 and the name of the initial registered agent of the corporation at that address is Thomas R. Hunt.

Article V

The corporation is to exist perpetually.

<u>Article VI</u>
