The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be: INTERMAX MEDIA INCORPORATED

The address of the principal office of this corporation shall be 8418 - 15th Way North, St. Petersburg, FL 33702, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any and all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 5,000 shares of common stock having NO par value per share.

#### ARTICLE IV. REGISTERED AGENT

The corporation elects to have preemptive rights.

#### ARTICLE VII. SPECIAL PROVISIONS




