1. NAME OF CORPORATION AND INITIAL ADDRESS: The name of this corporation shall be BUBBLES, INC. and its address is 252 N. Tyndall Parkway, Panama City, Florida 32404.

2. TERM OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.

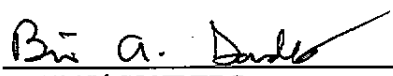
