ARTICLES OF INCORPORATION OF JARRETT MICHAEL CORP.

The undersigned, desiring to form a corporation (the "Corporation") under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I CORPORATE NAME
