ARTICLES OF INCORPORATION

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, and each of whom are licensed or otherwise legally authorized to render the professional services herein described, hereby associate themselves together to form a professional service corporation under Chapter 621 of the Laws of the State of Florida.

ARTICLE I NAME AND ADDRESS

The name of the corporation is Mainstream Rehabilitation, Inc. The Principal business address of the corporation is in care of 6876 Sedgewick Court, Fort Myers, Florida 33919.

ARTICLE II NATURE OF BUSINESS

This corporation may engage in each and every aspect of outpatient physical rehabilitation but only through its officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional services; and engage in any and every other activity permitted from time to time for a corporation so formed to engage in.

ARTICLE III CAPITAL STRUCTURE

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is One Thousand (1,000) shares of common stock of the same class each having a par value of One Dollar (\$1.00). The stockholders shall have no preemptive rights with respect to the stock of the corporation, and the corporation may issue and sell its stock from time to time without first offering such shares to the then stockholders.

ARTICLE IV TERM OF EXISTENCE

This corporation shall commence upon the filing of these Articles and shall have perpetual existence thereafter.

ARTICLE V INITIAL ADDRESS

The street address of the principal office of the corporation is to be in care of 6876 Sedgewick Court in the City of Fort Myers, Florida. The Board of Directors may

designate such other and additional addresses and/or places for the principal office of this corporation as it may from time to time see fit.

ARTICLE VI DIRECTORS

The business and the affairs of this corporation shall be managed by a Board of Directors, which shall be elected by the shareholders and serve as provided in the Bylaws. The number of the members of the Board of Directors may either be increased or decreased from time to time by the Bylaws but shall never be less than one (1). 
