THE ARTICLE OF CORPORATION OF ALTAMATE INC.  
TO: SECRETARY OF STATE OF FLORIDA, TALLAHASSEE, FLORIDA.

We, the undersigned natural person of the age of thirty-one or more, acting as incorporators of a corporation under title 607.164, of the Laws of the State of Florida, adopt the followings Articles of incorporation for such corporation.

1. The name of the corporation, hereinafter referred to as the corporation shall be ALTAMATE INC.
2. The duration of the corporation shall be perpetual.
3. The objects and purposes for which this corporation is organized is the ownership and management of a business dedicated to the provision of health care services and any other business permitted by law.
4. The aggregate number of shares which the Corporation is initially authorized to issue is one thousand (1,000). There shall be one class of stock with a par value of one dollar (1.00). There shall be no preferences, qualifications, limitations, restrictions or special rights with respect to the one class of stock.
5. Shareholders have the presumptive right to acquire additional share of stock.
6. Provisions for the regulation of the internal affairs of the Corporation are contained in the By-Laws of Corporation.

7. The Corporation will not commence business until at least one thousand dollars ( \$1,000) has been received by it as considerations for the issuance of shares.
8. The initial registered office and principal place of the Corporation shall be located at 17520 NW 61 CT N Miami, Florida 33015. The initial registered agent is Ms. Elukia Pennerman.
9. The following person shall constitute the initial Board of Directors of the Corporation, and shall serve until the first annual meeting or until his successors shall be elected: Ms. Elukia Pennerman, who resides at 17520 NW 61 CT N Miami, Florida 33015 and Andrew Pennerman, who resides at 17520 NW 61 CT N Miami, Florida 33015.
10. The incorporators of this Corporation are Elukia Pennerman and Andrew Pennerman who reside at the address stated in paragraph 9.
11. The Article of incorporation shall constitute a binding agreement and may be amended by the affirmative vote of majority of the Board of Directors in office.
12. The registered agent hereby is familiar with and accept the duties and responsibilities as registered agent for this Corporation.
