

The undersigned incorporators hereby form a corporation for profit under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation shall be:

DOORS PLUS, INC.

The address of the principle office of this corporation shall be at 1822 S.W. 21st Lane, Cape Coral, Florida, 33914, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage in every aspect of the business of making doors and cabinets. This corporation may engage or transact in any or all lawful activities or business permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III. CAPITAL STOCK


