### ARTICLES OF INCORPORATION FILED

## ROBERTS FINANCIAL PLANNING SERVICES, INC. SECRETARY OF STATE

#### ARTICLE I - NAME

The name of this corporation is ROBERTS FINANCIAL PLANNING SERVICES, INC.

#### ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

#### ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended. The general nature of the business to be transacted by the corporation shall be as follows:

- (a) To solicit, encourage and promote sales or purchases of securities from the general public;
- (b) To purchase, sell, lease, operate, own, hold, transfer, convey, mortgage, or otherwise encumber, trade, exchange and generally deal in real estate and personal property of every kind, nature and description wheresoever located, both tangible and intangible and including choices in action, either as owner, broker, agent or factor. To engage in lawful activity and to institute, participate in and promote commercial, mercantile, financial and industrial enterprises and operations;

- (c) In the purchase or acquisition of property, business rights or franchise, or for additional working capital, or for any other objective in or about its business affairs and without limit as to amount: to incur debts and to raise, borrow, and secure the payment of money in any lawful manner, including the issue and sale or other disposition of bonds, evidences of indebtedness, whether secured by mortgage, pledge, deed of trust or otherwise. The corporation may issue its stock for any lawful purposes, including the acquisition of any other entity;
- (d) Any stock issued by this corporation may qualify under Section 1244 of the Internal Revenue Code of 1954, and as same may be amended;
- (e) This corporation may, at its option, avail itself of the provisions of Part II of the Florida Corporation Act pertaining to closed corporations, Sec. 608.70 et. seq. of the Florida Statutes, and as same may be amended;
- (f) This corporation shall have all of the general powers together with all additional and specific powers granted by the Laws of the State of Florida, as well as implied powers, in carrying out the foregoing express powers;
- (g) The foregoing clauses shall be construed both as objects and as powers, but no recitation, expression or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent therewith are hereby included.

#### ARTICLE IV - STOCK

This corporation is authorized to issue one thousand (1,000) shares of One Dollar (\$1.00) par value common stock which shall be designated "common shares".

#### ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

#### ARTICLE VI -- INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 1002 West 23rd Street, Suite 390, Panama City, Florida and the name of the initial registered agent of this corporation is RALPH C. ROBERTS, JR.

#### ARTICLE VII - INITIAL BOARD OF DIRECTORS

This corporation shall have one director constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaws; however, there shall never be less than one director nor more than five. #### ARTICLE VIII - INCORPORATORS

This corporation reserves the right to amend or repeal any provision contained in these Article of Incorporation, or any amendment hereof, by a majority vote of the Board of Directors, and any right conferred upon the shareholders is subject to this reservation.

#### ARTICLE X - INDEMNIFICATION

The corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

#### ARTICLE XI - CAPITAL

This corporation shall begin business with a capital of not less than FIVE HUNDRED DOLLARS (\$500.00).


