The reason my annual reports were not submitted was due to my address not changing as I moved my office. I left the address on your record in October 1998 and moved to 420 West Beach Dr. After residing on West Beach Drive for a couple of years, I moved to my current location at 801 Jenks Ave. Suite C.
