I realized two days ago that my corporation was administratively dissolved on 9/24/99. Per instructions received today by phone, I'm including this letter requesting a waiver and a check in the amount of \$900.

The reason my annual reports were not submitted was due to my address not changing as I moved my office. I left the address on your record in October 1998 and moved to 420 West Beach Dr. After residing on West Beach Drive for a couple of years, I moved to my current location at 801 Jenks Ave., Suite C Panama City, FL. At all times, my taxes have been current using the current address at the time of the submission. Being that I always filed using my FEI number, I'm surprised I was never notified of this situation. And due to the address you have on file is an old address, I never received the notifications. I would suggest that some thing needs to be done to merge the documents to identify this type of problem.

The check in the amount of \$900 represents \$150 for each year for years 1999, 2000, 2001, 2002, 2003, and 2004 (6 X \$150 = \$900). I was advised by phone yesterday that my specific situation would qualify to have the penalty waived as long as I submitted a letter explaining the situation.

If you have any questions, please notify me immediately and ask for Bobby Roberts. I want to resolve this situation as quickly as possible. I'm trying to establish a sales tax number.
