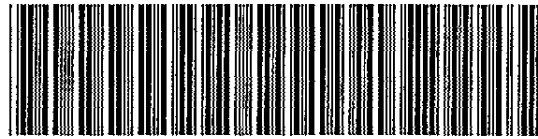


The principal office and mailing address of the Corporation will be 212 Ash Avenue, Melbourne Beach, Florida 32951.

All other Articles unchanged.



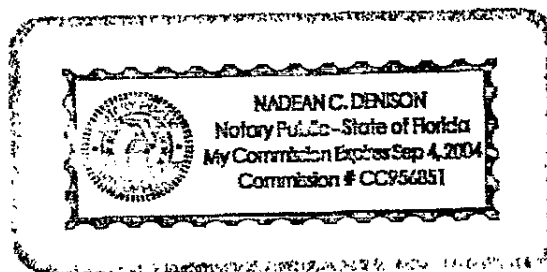
